#### PROJECT DESCRIPTION

- This project will be to design and replace all in-ground Fire Suppression piping at Discovery Park.
- Remove and replace approximately 8,500 lineal feet of Fire Piping, all Post Indicator Valves (PIV's), and Hydrants at Discovery Park.
- Re-route pipe as required by on site conditions. Upsize 10" pipe to 12" from city supply around the building to the risers. Replace the piping from risers to the building with 10" pipe.
- The project needs to account for the existing city main tie-in as well as the tie-in to the new city water main currently planned to be installed along N. Elm Street.

- Respondent & proposed team experience & capability to perform design/build services for this type project.
- Respondent & proposed team experience & capability to perform design/build services for the project, noting projects team members have worked on together.

- Respondent's utilization of cost estimating & a construction cost control plan to ensure budget is not exceeded.
- Respondent's ability to utilize scheduling throughout the entire project phases
- Respondent's capability to perform quality control process during entire project duration.
- Respondent's job site safety program.
- · Respondent's HUB Subcontracting policies & approach.

# What is a Historically Underutilized Business (HUB)?

It is at least 51% owned by an Asian Pacific American, Black American, Hispanic American, Native American, American woman and/or Service Disabled Veteran, who reside in Texas and actively participate in the control, operations and management of the entity's affairs.



### What is a HUB?

- •It is certified by the State of Texas.
- •It is a for-profit entity that has not exceeded the size standards prescribed by 34 TAC §20.23, and has its principal place of business in Texas.

- Special Trade Construction 32.9%
- Professional Services 23.7%
