#### **PROJECT DESCRIPTION**

- This project will be to renovate the Hurley Administration Building Mechanical, Electrical and Plumbing (MEP) systems.
- The primary purpose is to eliminate a significant amount of deferred maintenance and address life safety and code concerns.
- This building is an architecturally significant campus building.
- Life safety upgrades and renovations include a fire sprinkler system and a backup generator along with various MEP and accessibility improvements.
- Scope of Services will include pre-construction and CMAR services.
- Substantial completion no later than February 2027.

The project scope includes the following critical deferred maintenance:

- Replace existing chilled & hot water piping
- Replace Level 3 VAV boxes

NT SYSTEM

- Install controls for 3<sup>rd</sup> floor only, 2 AHU's and 17 VAVs
- Replace existing sanitary, domestic water & storm drain piping in the crawl space
- Replace existing power panels and branch wiring
- Install new emergency diesel generator
- Install fire sprinkler system with dedicated utility access and fire pump room
- Replace existing elevator to meet ADA accessibility standards
