PROJECT DESCRIPTION

- This project will be to renovate the Pohl Recreation Center to increase the fitness space.
- The project includes converting the current leisure pool natatorium into two levels of additional fitness space.
- The two floors would potentially increase the fitness space from 15,000 sq. feet to approximately 35,000 sq. feet.
- Includes retrofitting the natatorium with two levels that would be used for weights, fitness, group exercise, restrooms and personal training.
- Scope of Services will include pre-construction and CMAR services.
- Substantial completion no later than March 2027.



PROJECT DESCRIPTION CONTINUED...

The project scope includes the following key components:

- Major Structural and MEP Modifications: Pool decommissioned and repurposed;
 HVAC, dehumidification and ventilation systems redesigned; Electrical and plumbing infrastructure modifications.
- Space Optimization and Functional Enhancements: Expansion of weight training, cardio and group fitness areas; Integration of storage areas, restrooms, and personal training spaces; Accessibility upgrades.
- Minimizing Disruption to Existing Operations: Operations will remain open during construction. It is essential that a detailed phasing plan be in place to minimize impact on students and staff.
- Compliance with Building Codes and Campus Master Plan is required.



SUBMISSION REQUIREMENTS/CRITERION

- Ability to obtain bond for project-Letter from Bonding Company
- Proposed fees.
- Respondent & proposed team's experience & capability to perform preconstruction services & construction management services.
- Project execution plan & technical competence as a construction manager.
- Utilization of cost estimating & construction cost control plan insuring budget not exceeded.
- Utilization of construction scheduling throughout design & construction phases.
- Capability to perform a quality control process during entire project duration.
- Job site safety record.

What is a Historically Underutilized Business (HUB)?

It is at least 51% owned by an Asian Pacific American, Black American, Hispanic American, Native American, American woman and/or Service Disabled Veteran, who reside in Texas and actively participate in the control, operations and management of the entity's affairs.



What is a HUB?

- •It is certified by the State of Texas.
- •It is a for-profit entity that has not exceeded the size standards prescribed by 34 TAC §20.23, and has its principal place of business in Texas.
