PROJECT DESCRIPTION

- This project is to replace Aerco boilers in West and Maple Halls that have come to their end lifespan and need to be replaced with a new boilers (Intellihot).
- Project will require that the contractor have at minimum a State of Texas Journeyman Plumbing License.

WEST/MAPLE HALL INSTALL INTELLIHOT BOILERS

- demo Aerco Innovation 1060 #2 boiler.
- replace with Intellihot IQ1001.
- provide and install new condensate neutralization kit.
- replace pvc with cpvc at locations that pertain to the boiler in scope of work.
- provide and install new gas regulator if needed.
- test all new pipe, fittings, valves, and insulate with fiberglass insulation.
- provide and install appropriate labeling with directional arrows on piping associated with the boiler in scope of work.
- tighten all set screws on conduit coupling pertaining to boiler in scope of work.



CONTINUED PROJECT DESCRIPTION

- label electrical junction box that pertains to the boiler in scope of work with panel number and circuit number
- perform factory startup on new boiler.
- provide required temporary boiler operating permit and boiler installation report to be filed with TDLR.
- provide electrical work for installing a new circuit with proper sized breaker for the required electrical consumption of the new boiler. if needed.
- install an electrical circuit for a new carbon monoxide detector and install detector for new boiler to local state administration code, rule 65.206.
- . verify the flue has appropriate slope per code. If the flue does not have appropriate slope, bring it up to code. The flue pipe should be 6" Centrotherm.

IN ADDITION, MAPLE HALL BOILER:

The 6" Centrotherm flue piping should transition into the existing CPVC at the wall just before the chimney stack.

Maple boiler removal may require the use of equipment to raise old boiler out of lower level and use equipment to lower new boiler into the lower level.

What is a Historically Underutilized Business (HUB)?

It is at least 51% owned by an Asian Pacific American, Black American, Hispanic American, Native American, American woman and/or Service Disabled Veteran, who reside in Texas and actively participate in the control, operations and management of the entity's affairs.



What is a HUB?

- •It is certified by the State of Texas.
- •It is a for-profit entity that has not exceeded the size standards prescribed by 34 TAC §20.23, and has its principal place of business in Texas.



Why we do a HUB Subcontracting Plan (HSP)

- Texas State Law.
 - •Government Code Chapter §2161.252
 - Administrative Code §20.14
- •Demonstrates a "Good Faith Effort" (GFE) to diversify business opportunities.
- Responses that do not include a complete HSP must be rejected

- •Not signed.
- Separate PDF files.
- Company information incorrect/incomplete.
- •Not justifying the failure to meet State HUB usage goals.
- •If self-performing, not providing required information.
- •Section 2 does not match Methods "A" or "B".
- •Respondents not allowed 7 working days.
- •HUBs and minority chamber not contacted.
- •No documentation showing "GFE".
- •Missing any information that the UNT System HUB Area is not allowed to fill in for the submitting company



Remember...

- The submitting company's HSP is a binding document.
- •Contract language requires the submitting company to abide by the terms of the original HSP.
- •The HSP can be revised only with the consent of the UNT System HUB Area. The same "GFE" requirements will apply.
