PROJECT DESCRIPTION

- This project is located at Mean Green Village in Denton, Texas.
- Lovelace Stadium is utilized by the women's softball team.
- Services are to include updated dugouts and field lighting in addition to the construction of a new Clubhouse of approximately 8,000(gsf) gross square feet.
- Projected schedule is to have contract complete by June 2023, with Construction Manager Pre-Construction Services authorized in June 2023.
- Construction to be substantially complete no later than May 2024.
- Site visit will be conducted on Thursday, April 27, 2023 at 9:30am at Lovelace Stadium, 1500 Bonnie Brae Street, Denton, Texas. No other site visits will be conducted.



SUBMISSION REQUIREMENTS/CRITERION

- Proposed fees.
- Ability to obtain bond for project- Letter from Bonding Company
- Respondent & proposed team's experience & capability to perform preconstruction services & construction management services.
- Project execution plan & technical competence as a construction manager.
- Utilization of cost estimating & construction cost control plan insuring budget not exceeded.
- Utilization of construction scheduling throughout design & construction phases.
- Capability to perform a quality control process during entire project duration.
- Job site safety record.

- HUB Sub-contracting policies & approach Criterion G.

What is a Historically Underutilized Business (HUB)?

It is at least 51% owned by an Asian Pacific American, Black American, Hispanic American, Native American, American woman and/or Service Disabled Veteran, who reside in Texas and actively participate in the control, operations and management of the entity's affairs.



What is a HUB?

- •It is certified by the State of Texas.
- •It is a for-profit entity that has not exceeded the size standards prescribed by 34 TAC §20.23, and has its principal place of business in Texas.
