PROJECT DESCRIPTION

- This project is for the buildout of the retail space at the newly built dining hall, Eagle Landing located at 1415 Maple, Denton, Texas 76201
- The retail space is approximately 2,700 gross square feet (GSF) and is consistent with the institution's strategic land and campus master plan.
- The facility includes market area, coffee/bakery server and Which Wich server along with associated kitchen, preparation, storage, wash room, and other necessary support areas for a modern retail facility.
- The retail space is to provide the students and faculty a unique experience of a coffee shop and market, by the use of its materials, rich warm wood porcelain tile tones, and patina metal porcelain tile tones, in an intimate setting with lots of natural light.
- Projected schedule is to have contract complete by July 2022 with potential start date in July 2021.

What is a Historically Underutilized Business (HUB)?

It is at least 51% owned by an Asian Pacific American, Black American, Hispanic American, Native American, American woman and/or Service Disabled Veteran, who reside in Texas and actively participate in the control, operations and management of the entity's affairs.



- •It is certified by the State of Texas.
- •It is a for-profit entity that has not exceeded the size standards prescribed by 34 TAC §20.23, and has its principal place of business in Texas.


The HUB Program promotes equal business opportunities for economically disadvantaged persons to contract with the State of Texas in accordance with the goals specified in the 2009 State of Texas Disparity Study. The statewide HUB goals defined in 34 Texas Administrative Code (TAC) §20.13 are:

- 11.2 percent for heavy construction other than building contracts,
- · 21.1 percent for all building construction, including general contractors and operative builders' contracts,
- 32.9 percent for all special trade construction contracts,
- 23.7 percent for professional services contracts,
- 26.0 percent for all other services contracts, and
- 21.1 percent for commodities contracts.

- - Agency Special Instructions/Additional Requirements - -

In accordance with 34 TAC §20.14(d)(1)(D)(iii), a respondent (prime contractor) may demonstrate good faith effort to utilize Texas certified HUBs for its subcontracting opportunities if the total value of the respondent's subcontracts with Texas certified HUBs meets or exceeds the statewide HUB goal or the agency specific HUB goal, whichever is higher.
