#### **PROJECT DESCRIPTION**

• These two (2) projects are located at the Health Science Center campus in Fort Worth, Texas.

- Project 1 Gibson Library is a renovation of floors, 2, 3 & 4 of approximately 23,000gsf. Renovation includes finishes, flooring, evaluation of stairs, assessment of space utilization concerns & furnishings. Anticipated substantial completion December 2024.
- **Project 2** MET is a renovation of the 4<sup>th</sup> floor of approximately 11,300gsf. Renovation is to convert existing space into the new Nursing School Dean's Suite. Renovation will consist of private offices, hybrid classroom space, breakroom, open spaces, and conference/huddle rooms. Anticipated substantial completion June 2024.
- Site visit will be conducted on Tuesday, August 1, 2023 at 1:30pm at HSC campus, 3500 Camp Bowie Blvd, Fort Worth, Texas. We will meet at Gibson Library lobby to tour that building first; parking can be in Lot 6 on Clifton Street. No other site visits will be conducted.

- Utilization of construction scheduling throughout design & construction phases.
- Capability to perform a quality control process during entire project duration.
- Job site safety record.
