3) Would it be possible to temporarily relocate persons in the office areas on 2nd floor?


ANSWER: No, not possible. That is a critical area for IT function for the University.

4) Can you furnish the evacuation routes of both the MET and Gibson Library floors?










MEDICAL EDUCATION & TRAINING BLDG LEVEL 4 SCALE: 3/64" = 1'-0" DATE: 4-4-2022




















