# AMENDMENT TO SERVICE AGREEMENT

#### **TCM Contract # 2021-222**

This First Amendment to the Service Agreement ("Amendment") is effective September 01, 2021, and is entered into by the University of North Texas ("UNT"), and by Entrust One Facility Services, Inc.

WHEREAS, UNT and Entrust One Facility Services, Inc. entered into that certain Service Agreement ("Agreement") for a term commencing September 1, 2019, and ending August 31, 2020;

WHEREAS, UNT and Entrust One Facility Services, Inc. renewed the Service Agreement on July 27, 2021 for a term commencing September 1, 2020 and ending August 31, 2021; and

WHEREAS, UNT and Entrust One Facility Services, Inc. now desire to extend the term of the Service Agreement for an additional one-year period (and to further amend the terms of the Agreement as more particularly set forth below):

- 1. As regards Exhibit A of the Agreement, Sections 17A B of the Unit Price Schedule are hereby deleted in their entirety and replaced with the Unit Pricing Schedule found in Exhibit A of this Amendment.
- 2. Unless otherwise terminated in accordance with the provisions set forth in the Agreement or by mutual written agreement of the parties, the term resulting from this Amendment shall be for one (1) year, commencing September 1, 2021 and ending August 31, 2022, with three (3) options remaining to extend in one (1) year increments. Options to extend are by mutual consent and in writing.
- 3. This Amendment embodies the entire agreement between UNT and Entrust One Facility Services, Inc. with respect to the amendment of the Agreement. In the event of any conflict or inconsistency between the provisions of the Agreement and this Amendment, the provisions of this Amendment shall control and govern.
- 4. Except as specifically modified and amended herein, all of the terms, provisions, requirements and specifications contained in the Agreement remain in full force and effect. Except as otherwise expressly provided herein, the parties do not intend to, and the execution of this Amendment shall not, in any manner impair the Agreement, the purpose of this Amendment being simply to amend and ratify the Agreement, as hereby amended and ratified, and to confirm and carry forward the Agreement, as hereby amended, in full force and effect.
