**THIRD AMENDMENT TO THE LICENSE AGREEMENT**

This Third Amendment to the License Agreement (hereinafter “**Amendment**”), is entered into as of the first day of September 2019 (“**Effective Date**”), by and between University of North Texas (hereinafter “**Institution**”), and Campus Labs, Inc., located at 298 Main Street, Suite 600, Buffalo, NY 14202 (hereinafter “**Campus Labs**”).

WHEREAS, Institution and Campus Labs are parties to a License Agreement, effective as of September 1, 2017 (hereinafter “**Agreement**”); and any subsequent Addendums and Amendments, which identify the Programs and Services to be performed in the Agreement;

WHEREAS, Institution and Campus Labs now wish to amend and revise the Agreement for purposes of renewing the Engage with Modules Program to extend the Agreement (hereinafter “**Program(s)**”).

NOW, THEREFORE, the parties do hereby amend the Agreement in the following respects:

1. Institution engages and authorizes Campus Labs to provide services, as described below and attached herein.
2. Notwithstanding anything contrary contained in the Agreement or subsequent amendments thereto, the initial term of the Program(s) will end as set forth in the License Schedule A-III, attached herein.
3. The Term and Fees to Schedule A-III shall be added to the Agreement for purposes of renewing the Program(s), as attached herein.
4. The Product and Licensing Information to Schedule B-III shall be added to the Agreement for purposes of renewing the Program(s), as attached herein.
5. This Amendment may be executed in counterparts, each of which shall be deemed as an original, but all of which together shall constitute one and the same Amendment. The parties’ execution and delivery of this Amendment by facsimile, email, or electronic copies shall have the same force and effect as execution and delivery of an original.
6. Except as modified herein, all other provisions of the Agreement, including all other addendums, terms and conditions set forth in the Agreement, shall continue and remain in full force and effect.
