

### **Addendum to Collection and Reporting Services Agreement**

THIS ADDENDUM is entered into by and between <u>University of North Texas</u> (the "Organization") and Watermark Insights, LLC ("Watermark") as of <u>July 24, 2020</u> ("Addendum Effective Date"), and amends and supplements the Collection and Reporting Services Agreement by and between Watermark and Organization, dated as of <u>February 1</u>, <u>2015</u>, as previously amended, including by that Rider, executed <u>May 23, 2019</u> (the "Agreement").

- 1. INTERPRETATION. Except as amended and supplemented by this Addendum, the Agreement shall remain in full force and effect. In the event of any inconsistency between any of the terms set forth in this Addendum and any term or provision contained in the Agreement, the terms set forth in this Addendum shall prevail. All capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Agreement.
- 2. **SERVICE.** For all purposes of the Agreement (as amended hereby), the term "System" shall be amended to also include the services listed in Annex A to this Addendum.
- 3. AGGREGATED STATISTICS. Notwithstanding anything to the contrary in the Agreement, or any attachments, exhibits, or addenda thereto, Watermark may monitor Organization's use of the Service and collect and compile Aggregated Statistics. As between Watermark and Organization, all right, title, and interest in Aggregated Statistics, and all intellectual property rights therein, belong to and are retained solely by Watermark. Organization acknowledges that Watermark may compile Aggregated Statistics based on Organization Data input into the Services. Organization agrees that Watermark may (i) make Aggregated Statistics publicly available in compliance with applicable law, and (ii) use Aggregated Statistics to the extent and in the manner permitted under applicable law; provided that such Aggregated Statistics do not identify Organization or Organization's confidential information. Watermark will ensure that all Aggregated Statistics released, even sequentially, does not inadvertently contain data that can be aggregated in such a manner as to reveal identities. No de-identified data

may be shared without Client's authorization or until Vendor ensures compliance with law. "Aggregated Statistics" means data and information related to Organization's use of the Service that is used by Watermark in an aggregate and anonymized manner, including to compile statistical and performance information related to the provision and operation of the Service. "Organization Data" means, other than Aggregated Statistics, Materials and other information, data, and other content, in any form or medium, that is submitted, posted, or otherwise transmitted by or on behalf of Organization or an End User through the Service. Subject to the provisions of the Agreement, Organization Data and Materials will be treated in accordance with the Privacy Policy.

4. **TERM AND TERMINATION.** The annual subscription period of the Agreement with respect to the service added by this Addendum shall commence and expire as described in Annex A hereto, and shall renew and or terminate, as applicable, in accordance with the Agreement as amended hereby. The annual subscription period(s) and Fees for the Systems listed in the original Agreement shall not change.
