RECITALS

This Service Agreement is made and entered into by University and Contractor as of the Effective Date.

WHEREAS, University desires that Contractor provide the Services, and Contractor desires to provide the Services to and for the benefit of University;

THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, University and Contractor agree as follows:

AGREEMENT

- 1. <u>Provision of Services</u>. Contractor shall provide all necessary personnel, equipment, material, supplies, and facilities in the performance of the Services. Contractor shall perform the Services with that standard of professional care, skill, and diligence customarily and ordinarily provided in the performance of similar services.
- 2. <u>Term.</u> Unless otherwise terminated in accordance with the provisions set forth herein or by mutual written agreement of the parties, the initial term of this agreement shall begin on the Effective Date, and continue through the Completion Date, unless otherwise extended or terminated by the parties. Along with the initial term, this agreement will include three (3) options for renewal in one (1) year increments.
- 3. <u>Termination</u>. University may terminate this Agreement at any time upon sixty (60) days' prior notice. Either party has the right to terminate this Agreement if the other party is in default of any

obligation hereunder. Contractor shall be entitled to compensation for services rendered through the effective date of termination.

4. <u>Payment of Compensation</u>. University shall pay the Compensation to Contractor in accordance with the payment terms set forth above, provided that, if no payment terms are specified payment shall be made in accordance with Chapter 2251 of the Texas Government Code. Contractor must be in good standing, not indebted to the State of Texas, and current on all taxes owed to the State of Texas for payment to occur. - 5. <u>No Assignment or Delegation</u>. This Agreement, and the rights and obligations set forth herein, are for personal services and may not be assigned or delegated by either party without the express written consent of the other party.
- 6. <u>Property Rights</u>. University shall, at all times, retain ownership in and the rights to any creative works, research data, reports, designs, recordings, graphical representations, or works of similar nature that may be produced in connection with this Agreement or the Services. Contractor agrees that such works are "works for hire" and assigns all of Contractor's right, title, and interest to University.
- 7. <u>FERPA</u>. If Contractor has access to students' educational records, Contractor shall limit its employees' access to the records to those persons for whom access is essential to the performance of the Services. Contractor shall, at all times and in all respects, comply with the terms of the Family Educational Rights and Privacy Act of 1974, as amended.
- 8. <u>Public Information</u>. University shall release information to the extent required by the Texas Public Information Act and other applicable law. If requested, Contractor shall make public information available to University in an electronic format.
- 9. <u>Required Posting of Contracts on Website</u>. Contractor acknowledges and agrees that University is required by Section 2261.253 of the Texas Government Code to post each contract it enters into for the purchase of goods or services from a private vendor on its Internet website, including any terms and conditions otherwise marked confidential and/or proprietary.
- 10. Relationship of Parties. Contractor shall, at all times, act as an independent contractor and not as a partner, employee, or agent of University. Contractor shall not act or hold himself out to third parties as a partner, employee, or agent of University in the provision of the Services. University shall not have or exercise such control over the manner in which the Services are provided as would jeopardize the status of Contractor as an independent contractor. University will not withhold federal or state income tax or Social Security tax on behalf of Contractor. In addition, Contractor shall have no claim under this Agreement or otherwise against University for vacation pay, sick leave, unemployment insurance, worker's compensation, retirement benefits, disability benefits, or employee benefits of any kind. Contractor shall have the exclusive responsibility for the payment of all such taxes and arrangements for insurance coverage and shall discharge such responsibility fully. In the event the Internal Revenue Service or any other governmental agency should question or challenge the independent contractor status of Contractor, the parties hereto mutually agree that both Contractor and University shall have the right to participate in any discussion or negotiation occurring with such agency or agencies, regardless of by whom such discussion or negotiation is initiated.

- 11. <u>Non-Waiver</u>. No failure by either party to insist upon the strict performance of any covenant, agreement, term, or condition of this Agreement, or to exercise a right or remedy shall constitute a waiver. No waiver of any breach shall affect or alter this Agreement, but each and every covenant, condition, agreement, and term of this Agreement shall continue in full force and effect with respect to any other existing or subsequent breach.
- 12. <u>Indemnity</u>. Contractor agrees to indemnify and hold harmless University and its regents, officers, agents, and employees, from and against any liability, losses, or damages it may suffer as a result of claims, demands, causes of action, costs, or judgments against it arising out of any act or omission by Contractor in the provision of the Services.
- 13. Breach of Contract Claims Against University. University is required by law to provide notice that Chapter 2260 of the Texas Government Code establishes a dispute resolution process for contracts involving, goods, services, and certain types of projects. If Chapter 2260 applies to this Agreement, then the statutory dispute resolution process must be used by the Contractor to attempt to resolve all of its disputes arising under this Agreement.
- 14. Governing Law and Venue. This Agreement shall be construed and enforced under and in accordance with the laws of the State of Texas, and venue for any suit filed against University shall be subject to the mandatory venue statute set forth in § 105.151 of the Texas Education Code.
- 15. Israel Non-Boycott Verification. If the Agreement is subject to Texas Gov't Code Section 2270.002, Vendor hereby represents, verifies and warrants that it does not boycott Israel and will not boycott Israel during the term of this Agreement.
- 16. <u>Incorporation and Entire Agreement.</u> This Agreement incorporates the usual and customary University purchase order and the terms, conditions, and notices contained therein are included herein for all purposes. This Agreement, including any exhibits or addenda identified and incorporated by reference herein, and the corresponding University purchase order constitute the entire agreement between the parties and contain all the agreements between the parties with respect to Contractor and the provision of the Services. The parties expressly acknowledge that, in entering into and executing this Agreement, the parties rely solely upon the representations and agreements contained in this Agreement and no others.

EXHIBIT "A" SCOPE OF SERVICES

Contractor shall provide the following Services:

1. Minimum Requirements/Qualifications

- All ASL providers must have at least 2 years of experience.
- Contractor will be required to respond to an ASL request within 48 hours (2 business days).
- Contractor will be required to provide an ASL services provider for **every** classroom request.
- Contractor will be required to submit a monthly invoice to verify services. Invoice should
 include name of ASL provider, student name, class information, days of service, time of
 service, and travel time.
- If the assignment is cancelled more than 24 hours in advance, the Contractor will not charge for that assignment.
- The Contractor will charge travel time from the Contractor location to the University of North Texas.

- The Contractor will use certified ASL providers for all assignments.
- The Contractor will be responsible for finding an equivalent substitution in the event that the scheduled ASL provider is absent for any reason.

- All ASL interpreters must be certified by the BEI (State of Texas or NIC).
- All ASL providers will provide on-site ASL services.
- ASL providers will provide on-site ASL services for Deaf or hard of Hearing students in student organization meetings, advising meetings, and at University scheduled events when requested.
- ASL providers will be ten (10) minutes early for each class.
- The Contractor will communicate any student absences with the Office of Disability Access Student Services Coordinator.
- The Contractor will respond to questions or discrepancies in billing within twenty-four (24) hours.
- ASL interpreters will not access personal communication devices during assignments.

 - Travel Exception A: Travel will not be billed for back-to-back classes with less than sixty (60) minutes' break between classes.
 - Travel Exception B: Travel will not be charged for any assignments interpreted via video remote.

• Billing Criteria

- o Classes/Assignments going over one (1) hour will be billed at 15-minute increments for interpreting time over one (1) hour.
- o Classes/Assignments cancelled greater than twenty-four (24) hours will not be billed.

SECTION 1: INTRODUCTION

1.1 UNTS System Description

The University of North Texas System (UNTS) is seeking proposals for On-site ASL (American Sign Language) for all business units of the UNTS (NIGP commodity code 961-17). UNTS is a University system that is composed of the University of North Texas in Denton (UNT), the University of North Texas Health Science Center (UNTHSC) in Fort Worth and the University of North Texas at Dallas (UNTD). The UNT System Administration is based in downtown Dallas. The three independent universities of the UNT System have combined enrollment of just over 42,000 students across five major teaching locations, including each main campus as well as Frisco and downtown Dallas. Proposals submitted in response to this RFP shall be for goods and/or services provided to UNTS, UNT, UNTHSC and/or UNTD, as agreed to in writing by the parties.

1.2 Background

The University of North Texas has seen a rapid increase in the population of Deaf and Hard of Hearing students that require the services of on-site American Sign Language (ASL) providers as part of their accommodations. The need for on-site ASL providers requires the Office of Disability Access (ODA) to outsource this accommodation to an agency to fill this need.

Deaf and Hard of Hearing students are registered for academic courses with a wide variety of dates, times, majors and classes that will require the use of on-site ASL providers in order to allow students access to lecture. These students also participate in curricular and extra-curricular activities such as advising appointments, student organizations, class field trips, presentations, university programs, and meetings with professors; all of which will require the use of an on-site ASL provider. The time line above will aid the ODA in scheduling on-site ASL providers for both the Spring and Summer 2019 semesters using one agency, which will ensure continuity of services for our Deaf/Hard of Hearing students

1.3 Group Purchase Authority

Texas law authorizes institutions of higher education to use the group purchasing procurement method (ref. Sections 51.9335, 73.115, and 74.008, Education Code). Additional Texas institutions of higher education may therefore elect to enter into a contract with the successful Proposer(s) under this Section. Should another institution exercise this option the resulting contract and obligations shall be between that institution and the vendor with UNTS incurring no obligation as a result thereof.

Either party has the right to terminate this Agreement if the other party is in default of any obligation hereunder. Contractor shall be entitled to compensation for services rendered through the effective date of termination.

4. <u>Payment of Compensation</u>. University shall pay the Compensation to Contractor in accordance with the payment terms set forth above, provided that, if no payment terms are specified payment shall be made in accordance with Chapter 2251 of the Texas Government Code. Contractor must be in good standing, not indebted to the State of Texas, and current on all taxes owed to the State of Texas for payment to occur. Invoices and any required supporting documents must be presented to:

- 5. <u>No Assignment or Delegation</u>. This Agreement, and the rights and obligations set forth herein, are for personal services and may not be assigned or delegated by either party without the express written consent of the other party.
- 6. <u>Property Rights.</u> University shall, at all times, retain ownership in and the rights to any creative works, research data, reports, designs, recordings, graphical representations, or works of similar nature that may be produced in connection with this Agreement or the Services. Contractor agrees that such works are "works for hire" and assigns all of Contractor's right, title, and interest to University.
- 7. <u>FERPA</u>. If Contractor has access to students' educational records, Contractor shall limit its employees' access to the records to those persons for whom access is essential to the performance of the Services. Contractor shall, at all times and in all respects, comply with the terms of the Family Educational Rights and Privacy Act of 1974, as amended.
- 8. <u>Public Information</u>. University shall release information to the extent required by the Texas Public Information Act and other applicable law. If requested, Contractor shall make public information available to University in an electronic format.
- 9. <u>Required Posting of Contracts on Website</u>. Contractor acknowledges and agrees that University is required by Section 2261.253 of the Texas Government Code to post each contract it enters into for the purchase of goods or services from a private vendor on its Internet website, including any terms and conditions otherwise marked confidential and/or proprietary.
- 10. Relationship of Parties. Contractor shall, at all times, act as an independent contractor and not as a partner, employee, or agent of University. Contractor shall not act or hold himself out to third parties as a partner, employee, or agent of University in the provision of the Services. University shall not have or exercise such control over the manner in which the Services are provided as would jeopardize the status of Contractor as an independent contractor. University will not withhold federal or state income tax or Social Security tax on behalf of Contractor. In addition, Contractor shall have no claim under this Agreement or otherwise against University for vacation pay, sick leave, unemployment insurance, worker's compensation, retirement benefits, disability benefits, or employee benefits of any kind. Contractor shall have the exclusive responsibility for the payment of all such taxes and arrangements for insurance coverage and shall discharge such responsibility fully. In the event the Internal Revenue Service or any other governmental agency should question or challenge the independent contractor status of Contractor, the parties hereto mutually agree that both Contractor and University shall have the right to participate in any discussion or negotiation occurring with such agency or agencies, regardless of by whom such discussion or negotiation is initiated.
- 11. <u>Non-Waiver</u>. No failure by either party to insist upon the strict performance of any covenant, agreement, term, or condition of this Agreement, or to exercise a right or remedy shall constitute

a waiver. No waiver of any breach shall affect or alter this Agreement, but each and every covenant, condition, agreement, and term of this Agreement shall continue in full force and effect with respect to any other existing or subsequent breach.

- 12. <u>Indemnity</u>. Contractor agrees to indemnify and hold harmless University and its regents, officers, agents, and employees, from and against any liability, losses, or damages it may suffer as a result of claims, demands, causes of action, costs, or judgments against it arising out of Contractor's arising out of any act or omission by Contractor in the provision of the Services.
- 13. <u>Breach of Contract Claims Against University</u>. University is required by law to provide notice that Chapter 2260 of the Texas Government Code establishes a dispute resolution process for contracts involving, goods, services, and certain types of projects. If Chapter 2260 applies to this Agreement, then the statutory dispute resolution process must be used by the Contractor to attempt to resolve all of its disputes arising under this Agreement.
- 14. <u>Governing Law and Venue</u>. This Agreement shall be construed and enforced under and in accordance with the laws of the State of Texas, and venue for any suit filed against University shall be subject to the mandatory venue statute set forth in § 105.151 of the Texas Education Code.
- 15. <u>Incorporation and Entire Agreement</u>. This Agreement incorporates the usual and customary University purchase order and the terms, conditions, and notices contained therein are included herein for all purposes. This Agreement, including any exhibits or addenda identified and incorporated by reference herein, and the corresponding University purchase order constitute the entire agreement between the parties and contain all the agreements between the parties with respect to Contractor and the provision of the Services. The parties expressly acknowledge that, in entering into and executing this Agreement, the parties rely solely upon the representations and agreements contained in this Agreement and no others.
