PROJECT DESCRIPTION

- This project will be to construct new facility/facilities on the main UNT campus.
- It is anticipated that the construction will be in multiple phases with the initial phase constructing approximately 600 beds with a possible second phase of approximately 400 beds.
- Scope of Services will include pre-construction and CMAR services.
- Substantial completion anticipated to be March 2026.



SUBMISSION REQUIREMENTS/CRITERION

- Proposed fees.
- Ability to obtain bond for project- Letter from Bonding Company
- Respondent & proposed team's experience & capability to perform preconstruction services & construction management services.
- Project execution plan & technical competence as a construction manager.
- Utilization of cost estimating & construction cost control plan insuring budget not exceeded.
- Utilization of construction scheduling throughout design & construction phases.
- Capability to perform a quality control process during entire project duration.
- Job site safety record.

What is a Historically Underutilized Business (HUB)?

It is at least 51% owned by an Asian Pacific American, Black American, Hispanic American, Native American, American woman and/or Service Disabled Veteran, who reside in Texas and actively participate in the control, operations and management of the entity's affairs.



What is a HUB?

- •It is certified by the State of Texas.
- •It is a for-profit entity that has not exceeded the size standards prescribed by 34 TAC §20.23, and has its principal place of business in Texas.

- Special Trade Construction 32.9%
- Professional Services 23.7%

- Commodities 21.1%
